#### Suggestions for future activities/focus of Public Dock Committee

The current meetings are focused on planning for the August visit by the Whatcom County Parks & Recreation Commission. This is a great opportunity to showcase the island, but is not a forum to discuss the concept of a public dock. After this visit is over, the committee will return to monthly meetings to continue working toward specific goals.

#### Thoughts on Island Statistics and Demographics

Terry Terry suggests that the public dock committee look for ways to enhance the county's understanding of island life and who lives here. One example is to look at Birch Bay's successful effort to build their berm with a safe pedestrian walkway –

- Council of Governments was instrumental in getting project off the ground
- Built awareness of seasonal visitors and impact on getting funded using "Birch Bay by the Numbers"
- Quantified tax dollars generated by visitors spending money became a very important tool
- Provided data on demographics and illustrated voter influence
- Started to deliver the message ONE council member at a time in a structured way

## **Thoughts on Potential Activities for the Committee**

The group discussed ways that the Public Dock Committee could consider developing smaller goals along the very long path to getting a dock built.

One goal is to develop a more detailed plan to manage a response to an incident on the island.

We have talked a lot about organizing boats to move passengers on/off the island when the ferry is not available. Now we need a set of specific steps to help manage this response.

The committee might start by soliciting input from other islanders specifically for a ferry outage. Once we have that plan in place, maybe see who is interested in working toward a unified strategy for helping the community respond to *other* events and to cope with any aftermath.

What if power is out for 4 or 5 days, for example? This impacts many islanders, but we do not have a structured way to get the people who can help hooked up with the people who need help.

Maybe this means that the dock committee expands its mission? Or it might mean that a new advisory committee is formed? In any case – it would be a benefit to the community if we could put the dock committee's work over the past year to such good use.
